¿JACHIN RI AJCHAK KACHAKUN CHI UWACH JA?

Jun "ajchak kachakun chi uwach ja" are' jun winaq che kachakun chi uwach rachoch jun chi winaq. Ri uchak kub'ano ruk'a'am:

- Kichajixik ak'alab' on jun winaq yawab' on ri'j winaq chik
- Chak rech josq'inem
- Nik'aj chi chak rech uwach ja kab'an pa taq kachoch ri e ya'l chak

We taqanik man ke'uchajij taq ri ajchakib' kechakun chi uwach taq ja:

- Che man junelik taj kechakunik, pacha' kekil ak'alab' xa pa taq ramaj pa kachoch ri e ya'l chak
- Che e kachalaxik ri e ya'l chak on rech ri (kech) winaq (e) ya'om chajinem chi kech

RI AJCHAKIB' KECHAKUN CHI UWACH JA RAJAWAXIK KAKETA'MAJ

Are tzij ri taqanik rech chak rech ri tinamit Nueva York, chi'l ri Q'alajisaxik Echeb'alik kech taq ri ajchakib' kechakun chi uwach ja, at:

- Rajawaxik kaya jun tojb'al rech nik'aj chi ramaj b'anom chakunem che are 1 1/2 mul rech ri qas tojonik kab'anik we q'axnaq chi 40 ramaj ri chak pa jun wuqq'ij rech ri cholq'ij (We pa rachoch ri ya'l chak at k'o wi, rajawaxik kaya ri' ri tojb'al chi awech are taq q'axnaq chi 44 ramaj ri chak pa jun wuqq'ij)
- Kaya jun q'ij (24 ramaj) uxlanem pa jun wuqq'ij on, we kak'am chakunem pa ri q'ij ri', rajawaxik katoj nik'aj chi ramaj chi awech

- K'o kiya'talil che katoj ruk' oxib' q'ij chi kech man kechakun taj are taq q'axnaq chi jun junab' rumal ri ya'l chak

We katchakunik ruk' 40 ramaj pa jun wuqq'ij, xuquje' katch'uq rumal:

- Q'alb'al k'u'x rech tojonem chi kech ajchakib' we kakisok kib' pa ri chak
